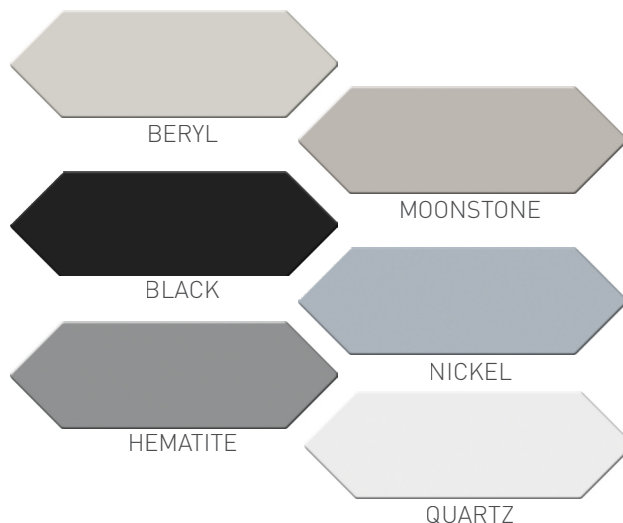

## INSTALLATION AND MAINTENANCE

It is suggested to lay tiles with a joint of 3 mm. ■ Using an unsanded grout such as Mapei Keracolor U is recommended. ■ As soon as the joints have fully set, it is recommended to proceed to initial cleaning with a neutral pH detergent. ■ Clean with a neutral detergent when needed. ■ When installing, mix the content of several boxes to ensure even distribution of the tile shading.

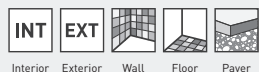

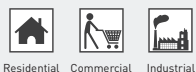

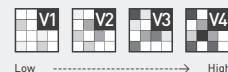
